Glove Box will not be held responsible for any cancellation by artists for this engagement. Should any cancellation occur Glove Box will do their utmost to replace artists by other qualified artists agreed upon by Purchaser.

Glove Box will not be held responsible for any injuries that may occur during this engagement.

Any contract riders will be the responsibility of the Purchaser unless negotiated for Glove Box to service.

CONTRACT RIDERS ATTACHED X NO CONTRAT RIDERS ATTACHED

Any fees required by SOCAN will be the responsibility of the Purchaser.

Any musicians booked by Glove Box, who are members of the American Federation of Musicians (A F of M), must adhere to A F of M regulations.

Any other artists booked in the same venue by another agency or directly by the Purchaser should be brought to the attention of Glove Box before the signing of this contract, and should the Purchaser wish to add further entertainment after the signing of this contract Glove Box must be informed for approval.

If this event is held outdoors, it is the responsibility of the Purchaser to provide a covered stage or a facility that the show can be held indoors.

If an artist/act is unable to appear, that portion of the fee will not be paid by the Purchaser. Another artist/act may be substituted, after negotiation, with the Purchaser.

Glove Box Entertainment. acts herein only as an agent for Purchaser and is not responsible for any act(s) of commission or omission on the part of either Producer, Artist, or Purchaser. In furtherance thereof and for the benefit of Glove box Entertainment it is agreed that neither Purchaser nor Producer will name of join Glove Box as party in any civil action or suit arising out of, in connection with or related to any act(s) of commission or omission on the part of Purchaser, Artist or Producer.

Should the show be cancelled by the Purchaser all deposits shall be forfeited.

This contract is binding rain or shine and full payment must be made.

In the event of as pandemic shut down this contract is null and void.
