THIS AGREEMENT made this day of June, 2021 BETWEEN:

MICHAEL ROSS HONSBERGER and BEVERLY SUSAN HONSBERGER

(hereinafter called the "Owners")

OF THE FIRST PART

and

THE CORPORATION OF THE CITY OF ELLIOT LAKE (hereinafter called "City")

OF THE SECOND PART

RECITALS:

Where the owners own Lot 67, Plan 1M-440;

And whereas the City owns the land that abuts Lot 67, Plan 1M-440, being Block 80, Plan 1M-440;

And whereas the owners wish to purchase that portion of Block 80, Plan 1M-440 abutting their property with a width of 9.44 metres and a depth of 34 metres, more or less, for the purpose of building a garage (the "property");

NOW THEREFORE, in consideration of the covenants herein contained, the parties hereby agree as follows:

- 1) The City shall commission a reference plan for the property and register it on title;
- 2) Upon the registration of the reference plan, the Owners shall purchase the property for the following compensation:
 - a) \$12,000.00 plus h.s.t.;
 - b) the cost of the survey and registration of the reference plan;
 - c) the legal fees and disbursements of the City in transferring the property.

- 3) Upon the transfer, the Owners shall forthwith apply to the City for a zoning amendment to consolidate Lot 67, Plan 1M-440 and the property;
- 4) The Owners will not commence any construction without a building permit and before a successful application to consolidate the two properties.
- 5) The sale of the property shall take place twenty days after the date of the registration of the reference plan.
- 6) The Owners shall obtain their own legal counsel.
- 7) Should the Owners not apply for the zoning amendment within six months from the date of closing or be unsuccessful in their application for the zoning amendment, they shall transfer the property back to the City for \$12000.00 plus hst (if applicable), less all of the legal fees and disbursements incurred by the City.
