## Appendix A

Further to the terms and conditions outlined it the Memorandum Of Understanding (MOU), the City of Elliot Lake, the following apply specifically to the use of the snowmobile staging area located at 46.360654, -82.562939:

- The lot is to be used as a snowmobile staging area and is being allotted to the Elliot Lake Snowbirds for the entirety of the 2022/2023 snowmobiling season.
- The City of Elliot Lake will plow the lot on a plowing schedule consistent with that of the Elliot Lake Airport
- The City of Elliot Lake will not be held responsible for costs incurred by plowing delays or damages to property caused by vehicles using an unplowed lot.
- The lot will not serve as public parking, solely as a parking/staging area for use by trail riders on OFSC Trail riders
- OFSC signage will be present on the site
- The City assumes no responsibility for loss, theft or damage of vehicles or equipment parked on site.
