Information & Terms: A non-refundable 50% deposit and an authorized signature on your contract will reserve the rental items and date. The balance is due one week prior to your event. Bookings made within one week, or less of the event date will require full payment. We reserve the right to set appropriate rules of conduct and age/weight/time limits in order to best facilitate your event and maintain a safe environment.

Corporate Contracts: Business cheques are accepted and must be received prior to delivery & set-up of rentals. Payments not received by the date of rental will result in a 3% interest charge.

Cancellation and Rain Policy: This contract, after signing, is a legal and binding contract. To cancel or reschedule, sufficient notice must be given - at least 48 hours prior to start of your event. Cancellation of event with less than 48-hour notice forfeits entire deposit. Cancellation after set-up has begun forfeits any refund. Postponement of event with at least 1-week notice may entitle you to use all or part of your deposit towards a timely rescheduled event at our discretion. Any rescheduled event is subject to availability of rental items at the time of notification of postponement.

Hold Harmless Provision: Lessee recognizes and understands that use of A Maze N Fun Inc. equipment may involve inherently dangerous activities. Consequently, A Maze N Fun Inc. agrees to indemnify and hold the City of Elliot Lake harmless from any and all claims, actions, suits, proceeding costs, expenses, damages and liabilities, including reasonable attorney's fees arising by reason of injury, damage, or death to persons or property, in connection with or resulting from the use of said equipment including, but not limited to the delivery, possession, use, operation, or return of the equipment. A Maze N Fun Inc. hereby releases and holds harmless the City of Elliot Lake from injuries or damages incurred as a result of the use of said equipment unless the City of Elliot Lake is operating the equipment and is deemed by a court of law to be negligent in its actions. A Maze N Fun Inc. also agrees to indemnify and hold harmless the City of Elliot Lake from any loss, damage, theft, or destruction of the equipment during the term of this contract and any extension thereof.

Inflatable Rentals Terms of Use:

1. There are risks, both known and unknown, using any inflatable or amusement device, including, but not limited to serious bodily harm. The risk of serious injury from participating in inflatable activities, although very minimal, does exist, as it does in all play and amusement activities. The customer recognizes and understands that use of the equipment may involve inherently dangerous activities.
2. Lessee agrees to notify all participants, their parents or guardians of "Use at Own Risk" policy. As the Lessee of the units, the safety of all participants shall be the customer's sole responsibility.
3. Adult supervision is required when participants are using the units. The Lessee understands that A Maze N Fun Inc. is not responsible for the supervision of participants while units are in use, unless otherwise arranged and stated in writing.
4. The weight and participant capacity for units is listed on each unit and should be strictly followed. Participants should be grouped by size.
5. A Maze N Fun Inc. recommends for safety that bounce house participants be 3 years of age or older, slide riders should be 5 years of age or older, jousting participants should be 10 years of age or older. Sumo Suit participants MUST be at least 14 years of age or older and at least 5 feet tall (please refer to Sumo Suit waiver and liability for a list of rules).
6. All participants must remove shoes, jewelry, keys, eyeglasses, and any other loose or sharp objects before using the inflatable units.
7. NO food, drinks, gum, "silly string", confetti or smoking is allowed in or near the units. Adding water to the units is strictly prohibited (with the exception of arrangements made for the Crayon Combo water pool). Units found with banned items or debris will result in a cleaning fee of \$250.
8. To avoid neck, back and other bodily injuries - no wrestling, flips or rough housing is permitted in the inflatable units. Participants shall not jump from platforms onto the sliding areas, climb the netting or roofs or bounce against the sides or near the doorway of the units.
9. Anyone with head, back, neck or any muscular-skeletal injuries or disabilities, pregnant women and others who may be susceptible to injury from falls bumps or bouncing are not permitted to use the units at any time.
10. Do NOT allow older children to jump with younger children.
11. If the units lose power or begin to deflate during operation or there is any reason to stop the units' use, the adult supervisor should immediately assist participants with safe evacuation from the units.

12. Units MUST be secured to the ground at all times to prevent tipping or injury. At no time should the units be removed from the installed location.
13. Units should not be used in inclement weather including winds exceeding 30 km/h sustained, rain and thunderstorms. If such weather occurs, the units should be evacuated and the blower turned off.
14. Participants shall be kept away from the blower(s) used to inflate the units.
15. Use common sense in supervising use of the units. If something does not look right to you stop the activity or occurrence immediately.
16. Event location area must be flat, dry and clear of rocks or any other debris to ensure the safety of participants. 2 feet of clearance is required from the top of all inflatable bouncers and slides, as well as a perimeter of 5 feet or more around the units. It is the customer's responsibility to clear the area prior to set up.
17. Lessee assumes full responsibility for any damage or loss to equipment during contracted time.
18. Lessee is responsible for providing power to operate blower units. A grounded 3-prong outlet can be used and must be within 100 feet of the unit. Generators can be rented from A Maze N Fun Inc. if required and must be kept outdoors and 20 feet away from the units.
19. In case of power failure at the event location A Maze N Fun Inc. is not responsible for any refunds.

COVID Protocols Applicable to this rental that are included in this quote and will be done in their entirety by A Maze N Fun Inc. and its staff are:

- Inflatable obstacle course and Maze will be shut down every 2 hours for 15 minutes to sanitize touchable surfaces
- Hand sanitizer will be provided at entrance of all units for usage
- All props and items for games will be disinfected and wiped down between every use (approx. 30 secs each time)
- Trained staff and supervisor will be on-site at all times to ensure social distancing and that protocols are being maintained

A Maze N Fun Inc. will:

1. Provide power cords to reach a minimum of 50ft.
2. Deliver, set-up and teardown.
3. Carry a liability insurance policy covering our services & equipment.

Lessee will:

1. Provide 0 110volt/20amp electric circuits.
2. Provide any required entrance and parking passes.
3. Provide a minimum of 0 adult supervisor(s) to operate the activities.

Food Machine Rentals Terms of Use:

1. It is the responsibility of the Lessee to obtain a special events food permit from your local Health Unit, when serving and or selling food at a public event.
2. It is the responsibility of the Lessee to obtain ice for use with the rental of the Snow Cone machine.
