1.1	Invoice ARD24-2177 for \$318,081.79 (includes HST), invoice ARD24-2178 for \$2,386,925.56 (includes HST) and invoice ARD24-2174 for \$48,532.85 (including HST) are currently due and require payment before the material can be manufactured and shipped to sit. The material shipment asap to keep the crews going for completion of works by mid to end of September.	
1.2	Level C estimate as design is being completed in parallel with construction currently	
3.1	Mobilization includes crew travel to the job site from the TRS office for the TRS crew, in addition to project preparations prior to departrure. TRS Technicians, to work 6 day weeks 10 hours per day.	
4.1	Client to prepare site for works and supply any access required, including access to work location requiring movement of utilitize, etc.	
5.1	The materials include roof sheeting, compression struts between trusses and X bracing between trusses, design is to be completed for these materials and estimates only are shown herein .	
5.2	Foundation work is not included, pending completion of soil investigation, and subsequent design and drawings
