# MUNICIPAL ENFORCEMENT QUARTERLY UPDATE REPORT AS OF JULY 2, 2024

The total occurrences from from April to June, 2024 are **476**. In 2023, from April to June, the total calls for service was **300**; this is a **36.97%** increase occurrences. Proactive patrols have been noted during this quarter.

From April to June, 2024, Municipal Enforcement has received 476 occurrences.

- **404** of those occurrences have been completed and closed; 85% of occurrences are completed and closed.
- 72 occurrences are currently open at this time. Most of the incidents that are currently open or are achieving compliance.
- Majority of the incidents during this quarter were for the following bylaws: Clean Yards, Garbage/Dumping/Storage, Animal Control and Parking/Traffic.

For April 2024, there were **146** occurences.

- 138 occurrences have been completed and closed.
- 8 occurrences are currently open.
- The majority of the closed occurrences were Animal Control, Snow and Ice, and Parking/Traffic.


For May 2024, there were 140 occurrences.

- 121 of those occurrences have been completed and closed.
- There are currently 19 open occurences from Febraury 2024.
- The majority of the closed occurences were Parking/Traffic, Animal Control and Taxi/Taxi Licensing.
- A Community Town Hall was held by the Municipal Enforcement Department on May 16, 2024 to discuss Clean Yards, Animal Control and Responsible Pet Ownership, Property Standards and Feeding Wildlife By-Laws.


For June 2024, there were **190** occurrences.

- 145 of those occurences have been completed and closed.
- The majority of the closed occurences were Animal Control, Clean Yards and Property Standards.
- At the time of this report, there are currently **45** open occurences from June 2024; which are: Clean Yards, Animal Control and Parking/Traffic.


## **Total Occurrences for April:**

# BUILDING DEPARTMENT QUARTERLY UPDATE REPORT AS OF JULY 2, 2024

The Building Department is working effectively to meet the needs of the community and are actively available to answer inquiries on building permits. Staff has worked to inform and educate the community on the Building Code and Municipal By-Laws.

The Building Department has conducted **91** inspections from April to June. Compared to April to June 2023 (**144** inspections conducted), this is a **36.8%** decrease and the table below shows the inspections conducted by month.
